WHICH DATA WE DEAL WITH

BROWSING INPUTS

The personal data processed of the users that just visit the web site (i.e. without sending messages or using reserved areas) is limited to browsing inputs, i.e. those for which the transmission to the web site is necessary for the functioning of the computer systems responsible for web site management and of the internet communication protocols. Belong to this category, for example, IP addresses or the computer domain used to visit the web site and other parameters relevant to the operating system used by user for the web site connection. The company collect these and other data (like for example the visit number and time spent on the web site) just for statistical purposes and anonymously in order to control the web site operation and improve its function. They are information that are not collected to be associated to other information concerning users and to identify them; however this data, by their nature, can allow the users identification through elaboration and association with data managed by third parties.

The legal basis of this treatment is the legitimate interest of the Controller to the technical management relevant to the functionality and security of the web site.

COOKIE

Cookies are small text files, that the web site inserts in the using device, such as computers or portable devices, saved in the directory used by the user's web browser. There are different kind of cookie, some for making more effective the web site use other to enable certain function.

The web site uses "technical" cookie, such as browsing or session cookie, i.e. tools useful for making functional and optimise the browsing and the enjoyment of the web site.

There are also analytics cookie that collect information, in an aggregate form, on users number and how they visit the web site. In particulate the web site uses the Google Analytics service , whose cookie policy can be reviewed to the address: <u>https://support.google.com/analytics/answer/6004245</u>.

In order to respect the privacy of our users, the service is used in a "anonymizeip" manner that allows you to masquerade the users IP addresses that are visiting the web site.

There are no profiling cookies.

HOW IS YOUR INFORMATION STORED AND FOR HOW LONG

In accordance with the written Regulations, the information systems and computer programs used by the data controller are configured in such way as to minimize the use of personal and identifying data; the data will be kept for the period of time strictly necessary to achieve the objectives pursued in practice and in any case, the criterion used to determine the retention period is based on compliance with the terms permitted by applicable laws and the principles of minimization of treatment, limitation of conservation and rational management of archives.

The navigation data are kept for technical analysis related to the functionality and security of the site for a period of 60days and then deleted. They may kept for a longer period and make them available to the judicial authorities to ascertain and identify the perpetrators of any computer crimes committed against the site or through the Web site.

The data obtained from analytical cookies are anonymized and do not allow to trace the identity of the user.

HOW WE ASSURE THE PERSONAL DATA SECUTITY AND QUALITY

The company undertakes to protect the security of the user's personal data and respects the provisions relating to security provided for the applicable rules in order to avoid data loss, misuse or unlawful uses and unauthorised access to them.

RECIPIENT OF PERSONAL DATA
